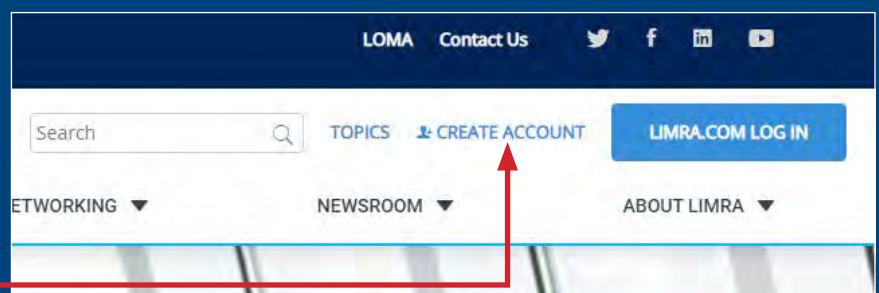

Overview of a LOMA Learning and LOMA.org Account

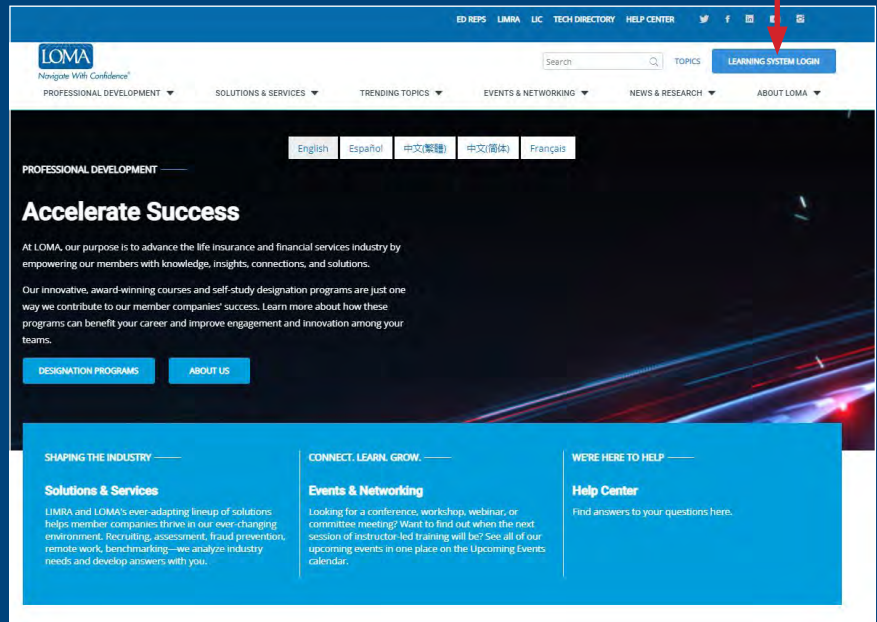
- Anyone can create an account

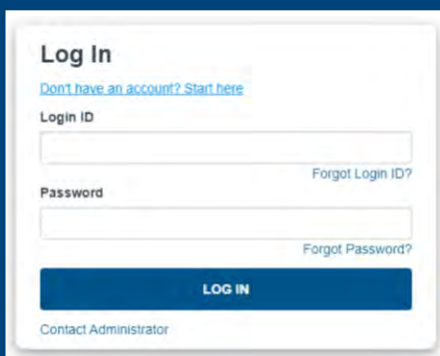

How to create your LOMA Learning account:

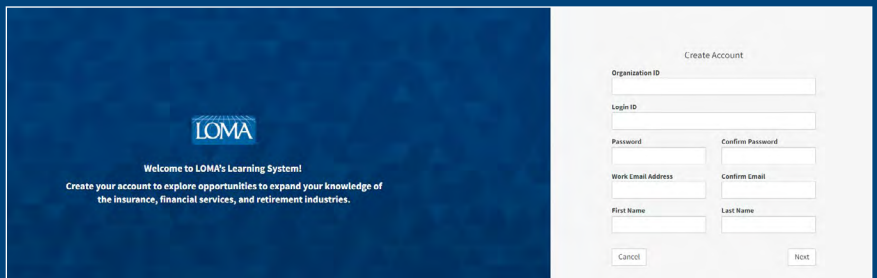
- 1 Go to LOMA.org
- 2 Click the **Learning System Login** button



- 3 Click **“Don’t have an account? Start here”**



- 4 Enter your Organization/Company ID in the first field if it has been provided to you by your Education Representative. **Note:** This field is not required, but you must enter a valid Organization/Company ID to receive any member discounts or access to special courses.



- 5 Enter a login ID and password that you will use when accessing this site. Your login ID must be at least four characters long.

- 6 Complete all remaining fields and click **“Save”** after this information is entered to return to the main registration screen.

- 7 Review the terms of use at the bottom of the screen, and click **“I Agree”** to note your acceptance of these terms.

Note: Registration cannot be completed without acceptance of the site terms of use.

- 8 Click **“Create”** to complete the registration process.
